Competition Rounds and Rules:

Round 1/Swimsuit: The contestants will present quarter turns with other contestants, wearing high heels and a 2-piece swimsuit of their choice, provided that no thong suits will be permitted. Jewelry may be worn in this round. No oil may be worn.

Round 2/Routine: The contestants will perform routines to music, no longer than two (2) minutes. Routines may include aerobics, dance, gymnastics or other demonstrations of athletic talent. The six mandatory moves must be incorporated into fitness routines. They are: 1-arm push-up; Leg extension hold; High kick; Straddle hold; Full split front; Full split side. Contestants will wear tennis athletic shoes and a fitness outfit of their choice. No jewelry or oil may be worn. Props carried on stage by the athlete and approved by Stonecutter Event Promotions in advance, are permitted. The working area for the fitness routines will be at least 32 feet wide by 12 feet deep.

Finals: The top 5 finalists in each height class will again perform their fitness routines and the one-piece swimsuit round, presenting quarter turns with other contests wearing their one-piece swimsuits and high heels. Final scores are combined with Prejudging scores (Round 1 and 2) to determine the final placements.
